Fidante Partners Limited (ABN 94 002 835 592, AFSL 234668) (**Fidante Partners, we, our, us**) is the Responsible Entity of the Alphinity Global Equity Fund (ARSN 609 473 127) and the issuer of this PDS. Our ultimate parent is Challenger Limited (ABN 85 106 842 371). References in this PDS to the **Fund** are to the Class A units in the Alphinity Global Equity Fund. No other class of units in the Alphinity Global Equity Fund is offered in this PDS.

We have appointed Alphinity Investment Management Pty Ltd (ABN 12 140 833 709, AFSL 356895) (**Alphinity** or the **investment manager**) as the investment manager of the Fund. The offer or invitation to subscribe for units in the Fund under this PDS is only available to persons receiving this PDS in Australia and New Zealand. If you are a Direct Investor, all correspondence pertaining to your investment will be issued by us. If you are investing through an investor directed portfolio service (**IDPS**) or IDPS-like scheme, you should contact your IDPS operator in the first instance with any query. Any complaints can be directed to us or to your IDPS operator. If you have any queries regarding your investment or if you would like a paper copy of the PDS or Additional Information booklet you should contact us. The Additional Information booklet provides additional information about the Fund.

The information in this PDS is up-to-date at the time of preparation. However, some information can change from time to time. If a change is considered materially adverse we will issue a replacement PDS. For updated or other information about the Fund (such as performance), please contact your financial adviser, call our Investor Services team or visit our website (our details are on page 8 of this PDS). We will send you a copy of the updated information free of charge upon request.

Alphinity has provided consent to the statements about it in the form and context in which they are included. 1. About Fidante Partners

Fidante Partners – the Responsible Entity

Fidante Partners is the Responsible Entity of the Fund. As Responsible Entity, we issue units in the Fund and are legally responsible to the unitholders of the Fund for its operation.

Fidante Partners forms long-term alliances with talented investment professionals to create, grow and support specialist, boutique funds management businesses. We have appointed Alphinity as the investment manager of the Fund. We provide back office, marketing, distribution, administration, and compliance support services to Alphinity, allowing Alphinity the freedom to focus on investing and managing the assets of the Fund.

A related entity of Fidante Partners has a partial equity stake in Alphinity. Neither we, nor any of our related entities, nor Alphinity, guarantee the repayment of your capital or the performance of your investment or any particular taxation consequences of investing.

Alphinity – the investment manager

Alphinity is an equities investment manager established in 2010. It is majority owned by its four founding principals, who have worked together since the early 2000s.

Alphinity aims to deliver consistent outperformance for its clients by investing in quality, undervalued companies which its research concludes are in, or about to enter, a period of earnings upgrades. Its process for identifying such companies includes a distinctive combination of fundamental analysis and quantitative inputs.

2. How the Alphinity Global Equity Fund works

The Fund is a registered managed investment scheme (also known as a managed fund) that is an unlisted Australian unit trust governed by a constitution together with the Corporations Act 2001 (Cth) and other laws. Managed funds pool individual investors' monies which are then used to purchase assets in line with the Fund's investment objective.

If you decide to invest in the Fund, you will purchase units in the Fund (rather than purchasing the assets directly) which represent a proportion of the value of the managed fund's collective asset pool. Certain rights are attached to these units and these rights are exercisable by the person who owns the units (referred to as **you, Direct Investor, or unitholders** throughout this PDS). For specific information on investing, please refer to '8. How to apply' in this PDS.

The number of units you can purchase will depend on the amount being invested and the investment unit price calculated for the day we receive your valid application form.

Investing

You can invest in the Fund as a Direct Investor, or an Indirect Investor.

The minimum initial investment amount is \$10,000, or \$1,000 when a Regular Savings Plan is established. For additional investments, the minimum one-off additional investment amount

is \$1,000 and the minimum Regular Savings Plan amount is \$100 per month. We can vary or waive the minimum investment amounts at any time.

For more information on how to make an investment, refer to '8. How to apply' in this PDS. All individual or joint investors in the Fund must be at least 18 years of age and all new investors must comply with our Customer Identification Program. Please refer to 'Customer Identification Program' in the Fund's Additional Information booklet available on our website.

Withdrawing

Once invested in the Fund, you can generally withdraw your investment at any time by making a withdrawal (subject to certain requirements).

For Direct Investors the minimum withdrawal amount is \$1,000. The number of units you can withdraw will depend on the amount being withdrawn and the withdrawal unit price calculated for the day we receive your withdrawal request. In some circumstances, such as when there is a freeze on withdrawals or withdrawals are spread, you may not be able to withdraw your funds within the usual period upon request. Refer to 'Withdrawal risk' in this PDS for more information.

Indirect Investors should contact their IDPS operator for withdrawal information.

Unit prices

As the market value of the assets invested in by the Fund rises and falls, so does the unit price. Unit prices are determined in accordance with the Fund's constitution and are usually calculated each New South Wales business day. We have a Unit Pricing Permitted Discretions Policy which sets out how we will exercise any discretion in relation to the unit pricing. You can request a copy of this policy by contacting us.

Processing

Generally, if your valid investment or withdrawal request is received in our Sydney office before 3:00pm Sydney time on a NSW business day (referred to as the **transaction cut-off time**), it will usually be processed using the unit price determined as at the close of business on that day. If your valid investment or withdrawal request is received after the transaction cut-off time, or on a non-business day, it will usually be processed using the applicable unit price calculated as at the close of business on the next business day. We will provide notice if we are to change the transaction cut-off time.

Frequency of distributions

The Fund generally pays distributions annually; however, there may be periods in which no distributions are made or we may make interim distributions. We do not guarantee any particular level of distribution. Distributions will generally be paid directly to a nominated Australian financial institution or reinvested in additional units in the Fund as soon as practicable after the end of the Fund's distribution period.

How distributions are calculated

Distributions you receive will generally represent your share of the distributable income of the Fund and can be made up of both income and net realised capital gains. Your share of any distribution depends on how many units you held at the end of the distribution period as a proportion of the total number of units on issue in the Fund at that time.

In certain circumstances, some income and/or net realised capital gains may be held back until the final distribution at the end of June to allow for market volatility.

4. Risks of investing in managed investment schemes

All investments carry risk. Different strategies carry different levels of risk depending on the assets that make up the strategy. Generally, assets with the potential for the highest long-term returns may also carry the highest level of risk.

When investing in a managed investment scheme, it is important to note that the value of assets in the managed investment scheme and the level of returns will vary. No return is guaranteed. Future returns may differ from past returns and investors may lose some or all of their money invested. Additionally, laws (including tax laws) that affect managed investment schemes may change in the future, which may have an adverse effect on the returns of managed investment schemes.

The level of acceptable risk will vary compared across investors and will depend upon a range of factors such as age, investment timeframe, risk appetite, the nature and size of other investments held, and the extent to which the Fund fits into a broader financial plan.

New Zealand investors need to be aware there are differences in how securities are regulated under Australian laws. For example, the disclosure of fees may be different and the rights, remedies and compensation arrangements available to New Zealand investors may differ.

Primary risks of the Fund's investment strategy include currency risk, security risk and market risk.


The significant risks of investing in the Fund are:

- **Counterparty risk**
The other party to a contract (such as a derivative contract or physical security trade) may fail to perform its contractual obligations either in whole or in part.
- **Currency risk**
Some securities held by the Fund may be denominated in a currency different to Australian Dollars. A change in the value of these currencies relative to the Australian dollar can affect the value of the investment. For example, a rise in the Australian dollar relative to other currencies may negatively impact the value of the investment. Conversely, a decline in the Australian dollar relative to other currencies may positively impact the value of the investment.
- **Derivative risk**
The value of a derivative is linked to the value of an underlying asset and can be volatile. Risks associated with using derivatives may include, but are not limited to, the value failing to move in line with that of the underlying asset and its potential illiquidity. While derivatives can offer the Fund the opportunity for higher returns, they can also magnify losses to the Fund.
- **Equity security risk**
The value of an equity security is affected by internal (e.g. changes in management) and external (e.g. market sentiment) factors that may impact the performance of the actual company over short or extended period of time.
- **Fund risk**
The risk that changes to the Fund such as termination, changes to fees, or changes in government policies (including taxation, regulations and laws that may affect the Fund) can have an impact on the potential investment return.
- **Liquidity risk**
The risk that the securities in which the Fund is invested, or the Fund itself, may become illiquid. The absence of an established market or shortage of buyers for an investment may result in a loss if the holder of the investment needs to sell it within a particular timeframe. This may also impact an investor's ability to withdraw from the Fund.
- **Market risk**
The possibility for an investor to experience losses due to factors that affect the overall performance of the financial markets outside the control of the Fund.
- **Service provider risk**
The Fund is, to a certain extent, reliant on external service providers in connection with its operation and investment activities. There is a risk with these arrangements that the service providers may default in the performance of their obligations or seek to terminate the services, affecting the investment activities of the Fund.
- **Withdrawal risk**
The risk that we may not meet the generally applicable timeframe for withdrawal requests, may suspend withdrawals or may deem the Fund illiquid.

5. How we invest your money

! When choosing what to invest in, you should consider the likely investment return of the Fund, the risks associated with investing in the Fund, and your own personal objectives, risk preference and investment timeframe.

Description of the Fund	<p>The Fund is managed by Alphinity. It seeks to build a portfolio of global stocks that is well diversified across different sectors, countries and currencies and aims to meet the Fund's investment objectives in a risk-controlled manner. The investment universe is comprised of stocks listed on global stock exchanges.</p> <p>The Fund is intended to be suitable for investors who look to invest for at least five years, are seeking high levels of return and are comfortable with high volatility, including the possibility of periods of negative returns.</p> <p>Investment approach</p> <p>Alphinity is an active, core Australian equities manager that believes a company's earnings ultimately will drive its share price over time. Alphinity believe the market is typically inefficient at accurately pricing future consequences of new information that will affect company earnings, therefore clearly identifiable characteristics exist for companies whose earnings ability is likely to be under (or over) estimated by the market, allowing an investor to exploit this inefficiency to create outperformance.</p> <p>Alphinity seeks to invest in companies with underestimated earnings potential. Specifically, the process searches for businesses with:</p> <ul style="list-style-type: none">• expected positive earnings and price momentum (Momentum);• backed by real cash flows and return on capital (Quality); and• trading at an attractive valuation (Value). <p>To identify such companies, Alphinity uses a combination of in-depth, fundamental research and specific quantitative factors throughout the process. The quantitative factors are generated in the proprietary Alphinity Quantitative Model (AQM). The two components are complimentary - when fundamental research and quantitative factors both point to the same conclusion, the investment decision is reinforced and as such is a powerful investment signal.</p> <p>Alphinity places equal emphasis on 'buy' and 'sell' decisions, as it considers that market earnings expectations for a company will eventually trend towards Alphinity's expectations. The opportunity to invest in an underestimated earnings growth situation has a limited time frame.</p> <p>Investment universe and portfolio construction</p> <p>The investment universe is comprised of stocks listed on global stock exchanges.</p> <p>The Fund can also invest in listed equity securities or hybrid equity securities such as convertible notes, redeemable preference shares and partly paid shares. The Fund has the ability to invest in unlisted stocks, but it is restricted to companies with a firm commitment to list within six months of prospectus issue date, and the combined value of such investments shall not exceed 5% of the total market value of the Fund.</p> <p>The final portfolio will typically be made up of between 30 and 45 stocks (with the flexibility to go as high as 70), constructing a balanced and diversified portfolio of stocks where the investment team has high conviction that the market is currently underestimating their earnings potential.</p> <p>Portfolio construction guidelines limit the Fund's exposure to any one company, sector, country or currency. The overall goal of Alphinity's portfolio risk management is to maximise exposure to risk factors where the team has deep insight, and control exposure to factors where the opposite is true. Stock selection is targeted to be the main performance driver. In the absence of a strong fundamental view, sector, country and currency risk exposures are minimised.</p>

Description of the Fund (continued)**Currency strategy**

The Fund is unhedged to the Australian dollar. However, it has the ability to hedge significant currency exposures relative to the benchmark through derivative contracts. This is to help manage currency risk, addressing the rare situation where our conviction on individual stocks might produce a portfolio with significant currency exposures (relative to the index).

¹These are asset allocation ranges for the Fund. If market movements, investments into or withdrawals from the Fund, or changes in the nature of an investment, cause the Fund to move outside these ranges, or a limit set out in this PDS, this will be addressed by us or Alphinity as soon as reasonably practicable.

Labour standards or environmental, social or ethical considerations

While Alphinity takes into account labour standards and environmental, social and ethical considerations when buying, retaining or selling underlying investments, it does not adhere to any particular set of standards. Alphinity will consider general factors such as, but not limited to, labour relations, potential environment impacts and whether a company has a clearly defined code of conduct and ethics policies. Alphinity's considerations of these factors is detailed further in the Additional Information booklet.

Changes to investment policy

The constitution of the Fund permits a wide range of investments and gives us, as Responsible Entity, broad investment powers. We may change the investment manager and/or vary the investment objectives, strategies, benchmarks, asset allocation ranges and processes of the Fund. We will give unitholders written notice of any material variation which we believe they would not have reasonably expected.

6. Fees and costs

Consumer advisory warning

Did you know?

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns. For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example, reduce it from \$100,000 to \$80,000). You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask the fund or your financial adviser.

Additional explanation of fees and costs

Management costs – Management costs are comprised of the management fee, performance fee (if payable), indirect costs, and recoverable expenses (including normal operating expenses, abnormal expenses and investment expenses). They do not include transactional and operational costs (i.e. buy/sell spreads) of the Fund or the transactional and operational costs of the underlying assets. Management costs are payable from the Fund's assets and are not paid directly from your investment.

If the Fund's daily return (after fees and expenses and after adding back any distributions paid) exceeds its defined Performance Benchmark, a performance fee may be payable. The Performance Benchmark is the MSCI World Net Total Return Index (AUD). The Fund is also required to meet an absolute return performance hurdle before a performance fee may be payable. The Performance Hurdle is the Reserve bank of Australia (RBA) cash rate target. Please refer to 'Performance fee' in the Additional Information booklet for more information on the performance fee.

Buy/sell spreads – The buy/sell spread is the difference between the investment unit price and the withdrawal unit price and is stated as a percentage. The buy/sell spread is not a fee paid to us. It is reflected in the unit price and is therefore an additional cost to you. The current buy/sell spread for the Fund is +0.25%/-0.25%. This may vary from time to time and we will provide notification of any changes on our website.

Other payments – We may pay fees from our resources to some IDPS operators because they offer the Fund on their investment menus.

! Additional fees may be paid to a financial adviser if one is consulted. You should refer to the financial adviser's statement of advice which provides details of the fees payable.

Can the fees change?

All fees can change. Reasons for this might include changing economic conditions and changes in regulation. We will give unitholders 30 days' written notice of any proposed increase in fees. We cannot charge more than the Fund's constitution allows. If we wish to raise fees above the amount allowed for in the Fund's constitution, we would first need to obtain the approval of unitholders. We also reserve the right to waive or reduce any of the fees and costs described in this PDS without prior notice.

7. How managed investment schemes are taxed

! Investing in a registered managed investment scheme is likely to have tax and/or social security consequences and you are strongly advised to seek professional tax advice.

The Responsible Entity has determined that the Fund will elect to become an Attribution Managed Investment Trust (**AMIT**) commencing from the 2018 financial year. It is intended that all determined trust components (i.e. assessable income, exempt income and non-assessable non-exempt income) will be attributed to members each year so that the Fund itself is not subject to tax. As an investor you will be assessed for tax on your attributed share of the Fund's taxable income, including any net capital gains. The Fund does not pay tax on behalf of Australian investors. Fidante Partners is not a registered tax (financial) adviser and is not licensed or authorised to provide tax advice. We strongly advise that you obtain your own professional advice regarding your position, as tax and social security laws are complex and subject to change, and investors' individual circumstances vary. New Zealand investors should obtain their own tax advice on the New Zealand and Australian taxation treatment of investing in Australian securities.

Indirect Investors

If you are an Indirect Investor, you must complete the documentation which your IDPS operator requires.

All investors

Under the Fund's constitution we can accept or reject investments into the Fund at any time and are not required to give any reason or grounds for such a refusal. To address money laundering and terrorism risks, verification of each investor's identity is a prerequisite for all new investors. If we do not receive all valid documents with your relevant application form we may not be able to commence your investment or may not process any future withdrawal requests until we receive the required documents.

Cooling-off rights

If you are a retail investor as defined in the Corporations Act 2001 (Cth), you may have a cooling-off right whereby you can change your mind about your investment in the Fund and ask for your money to be repaid. This cooling-off right must be exercised within 14 days from the earlier of:

- when you receive confirmation of your investment; and
- the end of the fifth business day after the day on which your units were issued or sold to you.

No cooling-off period applies to an investment placed through an IDPS operator. You should seek advice from your financial adviser or IDPS operator about the cooling-off rights (if any) that might apply to your investment in your IDPS.

Complaints

As part of our commitment to providing quality service to our investors, we endeavour to resolve all complaints quickly and fairly. Our policy is to acknowledge any complaint promptly after receiving it and investigate, properly consider and decide what action (if any) to take and provide a final response to you within 45 days (30 days in relation to privacy complaints). Indirect Investors

Investors accessing the Fund through an investor directed portfolio service (**IDPS**) or IDPS-like scheme (known commonly as a master trust or wrap account) may use, or be given, this PDS when deciding to invest in the Fund. These investors are referred to as Indirect Investors. Indirect Investors do not become unitholders in the Fund, nor do they acquire the rights of a unitholder. The operator of the IDPS (**IDPS operator**) acquires those rights and can exercise or decline to exercise them on behalf of Indirect Investors. Indirect Investors do not receive distributions or reports directly from us, nor do they directly participate in investor meetings or the winding up of the Fund if this were to occur. Indirect investors should direct all enquiries or complaints about the operation of their IDPS to the IDPS operator. In relation to complaints about the Fund, Indirect Investors may contact either their financial adviser, their IDPS operator, or us.

In addition to reading this PDS, Indirect Investors should carefully read the IDPS operator's offer document, which explains the service and the fees payable by the Indirect Investor to the IDPS operator. To invest, Indirect Investors need to complete the documentation which their IDPS operator requires.

New Zealand Investors
