### Target Market Summary

The Fund primarily invests in a diversified portfolio of microcap Australian companies. This product is likely to be appropriate for a consumer seeking capital growth and to be used as a small component of their portfolio where the consumer has a medium investment timeframe and a high risk/return profile.

The Fund seeks to build a diversified portfolio of primarily listed Australian companies with a market capitalisation of generally less than A\$300 million at the time they are first acquired on behalf of the Fund. Up to 10% of the Fund can be invested in unlisted companies, usually those that intend to list within 18 Months. Up to 10% of the Fund can be invested in New Zealand securities.

Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product to reduce volatility and minimise loss in a market down-turn. The consumer prefers exposure to defensive assets (such as cash or fixed income securities) that are generally lower in risk and less volatile than growth investments.
Capital Guaranteed	The consumer seeks a guarantee or protection against capital loss whilst still seeking the potential for capital growth (typically gained through a derivative arrangement). The consumer would likely understand the complexities, conditions and risks that are associated with such products.
Income Distribution	The consumer seeks to invest in a product designed to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (typically, high dividend-yielding equities, fixed income securities and money market instruments).
