### Target Market Summary

---

The Fund primarily invests in a diversified portfolio of specialised credit asset classes including both the public and private sectors. This product is likely to be appropriate for a consumer seeking capital stability and stable income and to be used as a small component of their portfolio where the consumer has a medium investment timeframe and a medium risk/return profile.

## Description of Target Market

### Investment Products and Diversification

Daily		The Product permits monthly redemptions under normal circumstances. Due to the nature of private debt markets where assets are traded less frequently, there is a risk that the applicable timeframe for meeting withdrawal requests in full may not be met. As a consequence, withdrawals from the Fund may be subject to a 10% withdrawal gate. The withdrawal gate allows us to satisfy requests on a pro-rata basis where the aggregate withdrawal amount in a given month exceeds 10% of the net asset value of the Fund. Investors in the Fund must be aware that it may take significantly longer to receive withdrawal proceeds than the generally applicable timeframe specified in the PDS.

Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product to reduce volatility and minimise loss in a market down-turn. The consumer prefers exposure to defensive assets (such as cash or fixed income securities) that are generally lower in risk and less volatile than growth investments.
Capital Guaranteed	The consumer seeks a guarantee or protection against capital loss whilst still seeking the potential for capital growth (typically gained through a derivative arrangement). The consumer would likely understand the complexities, conditions and risks that are associated with such products.
Income Distribution	The consumer seeks to invest in a product designed to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (typically, high dividend-yielding equities, fixed income securities and money market instruments).

Medium	The consumer is moderate or medium risk in nature, seeking to minimise potential losses (e.g. has the ability to bear up to 4 negative returns over a 20 year period (SRM 3 to 5)) and comfortable with a moderate target return profile. Consumer typically prefers a balance of growth assets such as shares, property and alternative assets and defensive assets such as cash and fixed income.
High	The consumer is higher risk in nature and can accept higher potential losses (e.g. has the ability to bear up to 6 negative returns over a 20 year period (SRM 6)) in order to target a higher target return profile. Consumer typically prefers predominantly growth assets such as shares, property and alternative assets with only a smaller or moderate holding in defensive assets such as cash and fixed income.
