Target Market Summary

The Fund adopts a relative value investment strategy to access a range of fixed income return sources. This product is most likely appropriate for consumers seeking potentially higher levels of return than cash and cash-like securities, protection against inflation and with the potential for some capital preservation and income. It is intended to be used as a small to core component of their portfolio where the consumer has a low investment timeframe and a low risk/return profile.

Investment Products and Diversification
