### Target Market Summary

---

The Fund primarily invests in a concentrated portfolio of small to medium Australian and New Zealand companies. This product is likely to be appropriate for a consumer seeking capital growth and to be used as a small component of their portfolio where the consumer has a medium investment timeframe and a high risk/return profile.

Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
