Target Market Summary

The Fund is a long/short product that primarily invests in a concentrated portfolio of generally between 30-50 companies listed in, or that gain significant exposure from, Asian (ex Japan) and emerging markets. This product is likely to be appropriate for a consumer seeking capital growth and are comfortable with high volatility including the possibility of periods of negative returns and to be used as a small allocation within a portfolio where the consumer has a medium investment timeframe and a very high risk/return profile.

Investment Products and Diversification
