Target Market Summary

The Fund primarily invests in a concentrated portfolio of generally between 30-50 companies listed in, or that gain significant exposure from, Asian (ex Japan) and emerging markets. This product is likely to be appropriate for a consumer seeking capital growth and are comfortable with high volatility including the possibility of periods of negative returns and to be used as a small allocation within a portfolio where the consumer has a medium investment timeframe and a very high risk/return profile.

Investment Products and Diversification

Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product to reduce volatility and minimise loss in a market down-turn. The consumer prefers exposure to defensive assets (such as cash or fixed income securities) that are generally lower in risk and less volatile than growth investments.
Capital Guaranteed	The consumer seeks a guarantee or protection against capital loss whilst still seeking the potential for capital growth (typically gained through a derivative arrangement). The consumer would likely understand the complexities, conditions and risks that are associated with such products.

High	The consumer is higher risk in nature and can accept higher potential losses (e.g. has the ability to bear up to 6 negative returns over a 20 year period (SRM 6)) in order to target a higher target return profile. Consumer typically prefers predominantly growth assets such as shares, property and alternative assets with only a smaller or moderate holding in defensive assets such as cash and fixed income.
