### **Credit Suisse Asset Management, LLC (CSAM), UBS Asset Management Integration**

Bentham Asset Management Pty Ltd (**Bentham**) is the investment manager for the Bentham Syndicated Loan Fund, Bentham Professional Syndicated Loan Fund, Bentham Syndicated Loan Fund NZD and Bentham High Yield Fund (the **Funds**). Bentham has appointed CSAM as sub-adviser of the Funds with responsibilities including security selection.

Credit Suisse Group AG (**Credit Suisse**), the indirect parent company of CSAM, was acquired by UBS Group AG (**UBS**) on June 12, 2023, with Credit Suisse being merged with and into UBS (the **Parent Merger**).

As part of the integration of CSAM with the UBS Asset Management business, it is anticipated that CSAM will be merged with and into UBS Asset Management (Americas) LLC (CRD# 106838/SEC# 801-34910) (**UBS AM Americas**), a registered investment adviser subsidiary of UBS, on or about May 1, 2024, with UBS AM Americas as the surviving entity (the **Merger**).

Upon the consummation of the Merger, UBS AM Americas (as successor to CSAM) will serve as the sub-adviser of the Funds. The Merger is not expected to have a material impact on the day-to-day operations of the CSAM business as it exists today or the personnel responsible for managing the Funds.
