Any disclosure in the Fund's PDS or Benchmarks Report pertaining to the Custodian or custodial arrangements should be read as a reference to State Street. The Fund's custodial arrangements will transition to State Street on or around 7 April 2025.

It is important to note the appointment of State Street as Custodian does not impact any other services or capabilities provided by a third party to the Fund.

State Street has provided its consent to the statements about it in the form and context in which they are included. State Street was not involved in the preparation and distribution of this PDS or Benchmarks Report and not responsible for the issue of those documents, nor is it responsible for any particular parts of those documents. State Street has not withdrawn its consent before the date of this notification.
